Service Agreement

1. Pahran Cricket Club (the "Debit User") will debit the credit account nominated in The Direct Debit Schedule of this Direct Debit Request as specified.
2. Pahran Cricket Club will give not less than 14 days written notice to the customer should it propose to vary the arrangements of this Direct Debit Request.
3. The customer(s) may request Pahran Cricket Club to defer or alter the payment amount specified in the Schedule of this Direct Debit Request. Requests authorising these changes may be made by phone or written advice to Pahran Cricket Club. Customer(s) may change the:
 - Due date of payment
 - Payment amount
 - Frequency of payment

Customer(s) wishing to vary the account details specified in The Schedule of this Direct Debit Request must provide signed authority for such changes to be effected.

4. In compliance with Industry's Direct Debit Claims Process, Pahran Cricket Club will assist the customer(s) disputing any payment amount drawn on the nominated account in The Schedule of this Direct Debit Request. Pahran Cricket Club will endeavor to resolve this matter within the Industry agreed timeframes. Customer(s) may visit any branch of their financial institution and complete a "Direct Debit System Claim Request" form to initiate the process.
5. It is the customer(s) responsibility to ensure at all times there are sufficient funds available at the due date of the debit drawing, to enable payment from the credit account as nominated in The Schedule of this Direct Debit Request.
6. It is the customer(s) responsibility to advise Pahran Cricket Club's Administration Manager, if account details have changed in the event of a credit card expiring, a lost or stolen card, or other circumstances.
7. Pahran Cricket Club advises the debit drawing will be made on the agreed due date, the 15th of each month for a 12 month period, as nominated in The Schedule of this Direct Debit Request.
8. Pahran Cricket Club requests the Customer(s) to direct all enquiries, disputes, requests for payment changes directly to them.

By agreeing to these terms and signing the Direct Debit Request Authorisation, the Customer(s) commits to paying the amounts payable, as detailed in The Schedule, on the 15th of each month for a 12 month period. The period will commence on the 15th of the month after receipt of signed Direct Debit Request Authorisation.

Pahran Cricket Club agrees to keep confidential all customer(s) records and account details contained in The Schedule of this Direct Debit Request unless authorized to release such information pursuant to a debit item dispute or similar event where the customer(s) has provided prior consent to do so.
